This MoU entered into as of dated Wednesday, 14/08/2024 by and between Department of B.C.A. Shri Shahaji Chhatrapati Mahavidyalaya, Kolhapur and Kanchan Software and Services Limited Liquidity Partnership (LLP) Kolhapur.

Objectives of the MoU:

- 1) To provide best internship opportunity to students.
- 2) To promote research aptitude and conduct research projects under the joint supervision.
- 3) To achieve outcome based training, placement and related services through industrial experience.
- 4) To improve professional skill development approach among the students.
- 5) To provide Technical Support in Training and Development as well.

Scope of MoU:

- 1) This is an MoU between the Company and the College in presence of officials of both the organization.
- 2) Will Provide Guest Lectures, Seminars, and Technical Workshops on College requirement basis and help in Placement of students in appropriate workplace.
- 3) Internship and placement of the eligible students from Shri Shahaji Chhatrapati Mahavidyalaya, Kolhapur strictly according to the extant rules and regulations of Kanchan Software and Services Limited Liquidity Partnership (LLP) Kolhapur.
- 4) Conducting exchange programs for students, faculty members as well as the employees of Kanchan Software and Services Limited Liquidity Partnership (LLP) Kolhapur.
- 5) Any other area which may be mutually beneficial to both the organizations.

Time Frame:

This MoU unless extended by mutual written consent of the institute, shall expire in FIVE YEARS after the effective date specified in the opening paragraph. However, on review, it shall be extended for another five years by mutual consent.


Confidentiality & Coordination:
