MEMORANDUM OF UNDERSTANDING

For Academic Exchange and Cooperation

Between

Department of English

SHRI SHAHAJI CHHATRAPATI MAHAVIDYALAYA,

DASARA CHOWK, KOLHAPUR

And

Department of English

YASHWANTRAO CHAVAN (KMC)

COLLEGE, GANGAVESH, KOLHAPUR



1) **Shri Shahaji Chhatrapati Mahavidyalaya**, having its registered address as 2968 'C' Ward, Dasara Chowk, Kolhapur (M. S.) Pin. 416002 by Dr. R. K. Shanediwan being the Principal of the college, hereafter referred as the college being the **First Party**.

2) **Yashwantrao Chavan (KMC) College**, having its registered address as 2032 'A' Ward, Dhatri Galli, Gangavesh, Kolhapur - 416 012 by Dr. P. P. Nagaonkar being the I/C Principal of the college, hereafter referred as the college being the **Second Party**

This **Memorandum of Understanding** is signed today on **Monday**, dated **19th July 2021** between the first and the second party for the purpose of Academic Exchange, Cooperation and Collaboration. The details of this MoU are as follows:

A. AIMS AND OBJECTIVES:

This MoU between the Department of English of Shri Shahaji Chhatrapati Mahavidyalaya, Kolhapur and the Department of English of Yashwantrao Chavan (KMC) College, Kolhapur is made with the following aims and objectives:

1. To arrange the exchange of faculty and students between both the parties for academic cooperation.
2. To carry out various academic activities collaboratively to encourage peer learning.
3. To exchange academic material and resources for the development of the students.
4. To carry out joint research activities in the field of English language and literature.

B. ROLES AND RESPONSIBILITIES:

- 1) In order to achieve above aims and objectives, a detailed plan may be agreed upon between both the two parties.
- 2) It is implicit that the every activity undertaken under this agreement is approved by the appropriate official at each institution and must fall within academic and physical constraints.
- 3) This agreement may be modified at any time after due consultation between both the parties.



C. DURATION:

This MoU, unless extended by mutual written consent of both the parties, shall expire in FIVE YEARS after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended for ANOTHER FIVE YEARS by mutual consent.

D. TERMS AND CONDITIONS:

- 1) This MoU may be amended, renewed and/or terminated by mutual written agreement of both the parties at any time.
- 2) Either party shall have the right to terminate the MoU upon 30 days prior written notice to the other party.
- 3) The expenditure for any activity is to be borne by the organizing party.

E. COORDINATORS:

Heads of both the institutions will designate persons who have responsibility of coordination and implementation of this MoU.
