Provision 1.

Prof. Dr. Jaya Laxmi Pradhan, Chief, Padmakanya Multiple Campus, Kathmandu, and Dr. R. K. Shanediyan, Principal, Shri Shahaji Chhatrapati College, Kolhapur have agreed on the following clauses of memorandum of understanding (Mou) and signed, and these are the objectives of this MoU:

1. To exchange Faculty program,
2. To conduct mutual research and teaching,
3. To establish academic relation between the two parties, and
4. To make arrangements for exchange of education activities.

Provision 2.

Department of Sanskrit, Journalism and Hindi, Mr. Dilli Ram Sharma Sangroula, Padmakanya Multiple Campus, Kathmandu, Nepal and Shri Shahaji Chhatrapati College, Prof. Dr. Saroj Patil, Kolhapur, Maharashtra, India have agreed to cooperate in the following subjects:

1. Hindi Language and Literature,
2. Hindi Language Technology,
3. Hindi-Nepali-Marathi-English Dictionary,
4. Nepali Hindi Overseas Literature Study,
5. Exchange of Culture, Fashion and Visit of Different Places, and
6. Hindi, Nepali, Marathi Film and Theater



Provision 3.

To complete these investigations, two sides will deepen its cooperation in the following ways:

1. By implementing joint research projects,
2. Academics, trainees, technical-administrative staff and other experts,
3. Free access to libraries and research available at participating institutions for research,
4. Participation in conferences, symposium in scientific papers,
5. By joint publication of results obtained in joint research projects, and
6. Any other form of cooperation will be done to achieve the objectives of MOU.

There will be necessary amendment on the provision of MoU if need be. The parties can define the procedures regularly for the implementation of this MoU.

Provision 4.

There will be the management of financial resources for achieving the objectives of this MoU within the limits of the rules of each country.

Provision 5.

This MoU last for 5 years after the signature of both parties. Every person involved in all activities contemplated by this MoU shall be liable to the Head of the both institutions.

Provision 6.

The contracting parties will extend the tenure of agreement by prior approval of Head of the institutions. In case of a decision to renew the agreement for the



next period, the pattern of provisions within the final year of the agreement will be exchanged of letter by the MoU parties.

Provision 7.

The existing agreement will be part of legal document between the parties.
